**Deadlines:** Applications received by the 5th of May deadline will receive a space guarantee if available following the approval process. You will receive a phone call confirmation.

**Spaces:** Spaces are 10' by 10' and available in multiples of 10' up to a maximum of 4 spaces. Trailer units and 20' box spaces are available but limited. These spaces should be reserved early. Please notify us if you have a trailer or special need.

**Placement:** Location will be assigned in areas suitable for your display based on your prior participation in our event or the date your entry is received. Please be sure to submit your application soon to be able to claim spaces available on a first come/first served basis. Exceptions will be made to non-profit groups or clubs supported by the North Modesto Kiwanis Club.

**Terms:** Checks or Credit Card information must accompany all applications.

**Application deadline for non-food vendors: May 5, 2025.**

Vendors applying after May 5 will be advised of the possible availability of space but no guarantees can be made.

**Vendor Schedule:** Check-in for set up Friday, June 6 from 7:30 a.m. to 2 p.m. Check-In Saturday, June 7 from 6 a.m. to 8 a.m. You must be set up and vehicles other than show cars must be removed by 8 a.m. Saturday. Show hours 9 a.m. to 5 p.m. Saturday and 9 a.m. to 3 p.m. Sunday. All Vendors should be loaded and off the show grounds by 5 p.m. Sunday.

**Check-in at Designated Check-In Site:** You must check in at the designated location on the Festival grounds before setting up. You will receive: 1) Vendor Badges (3 maximum) 2) Your space assignment. 3) Other info as needed.

**Directions to the Site:** Traveling South on Hwy 99 take Briggsmore/Carpenter off ramp (Exit 229). Turn right onto Carpenter Road. Then turn right on Blue Gum Ave. Ask or look for guidance to Vendor Check-In. GPS address: 2201 Blue Gum Ave.

**Exhibit Restrictions:** North Modesto Kiwanis (NMK) reserves the right to return applications for booth space at NMK's singular and sole discretion if in our opinion it is in the interest of the Event. NMK reserves the right to make changes at any time including after space assignments are determined if NMK determines such changes benefit the Festival.

**Cancellation Refund:** Any space cancelled in writing prior to May 30 will be refunded in full. A mailed cancellation is required. Contact us as early as possible by phone as well for the sake of others. No refunds after June 1. This policy will be strictly enforced. The Festival will have Armed Security Friday and Saturday nights beginning at 5 p.m. However do not leave your own setup unsecured. If you leave anything behind you assume the risk of loss. Be careful with your own security.

**Placement:** Vendors cannot double up to reduce space cost unless prior agreement is made in writing. Exeptions will be made to non-profit organizations supported by the NMK. Your vendor spot will have your name on 2 placards.

**Waiver and Indemnity:** Exhibitor expressly releases NMK, the Event facility and their respective directors, agents, members and servants from any damage or injury that may happen to the Exhibitor or its agents, employees or property from any cause whatsoever except the gross negligence or willful misconduct of the former. The Exhibitor is responsible for any and all demands on account of any injury, death or damage occuring upon any area used by Exhibitor. Exhibitor shall defend, indemnify and hold harmless NMK, its officers, members and agents from and against all claims, demands, actions, penalties and liabilities of every kind and description. Contact your insurance broker for coverage if you are concerned.
